Km 28.950, km 30.400, km 33.950, km 36.230, km 38.730, km 41.320, km 48.400, km 49.800 & km 51.300 on NH-361 under RDSS Scheme of Tuljapur - Ausa section of NH-361, Total length - 540m in the State of Maharashtra- Reg.
