**Subject-** Proposal of M/s Gujarat Gas Limited for permission for laying 4" dia steel pipeline to set up a piped natural gas distribution network in Pardi taluka & surrounding area of Valsad district across to NH 848 (Pardi-Chival-Jogvel road) at Ch 4.340 in village Kumbhariya, taluka-Pardi, District Valsad in the State of Gujarat-Reg.

The Roads and Building Department, Government of Gujarat vide letter no. 
