It is to submit that M/s. Mega City Gas Distribution private limited, vide reference 1st cited has requested to issue permission for laying of 100mm dia CS-Pipe & 40mm PVC pipe line on NH-16 at Km 10+579 to Km.14+582 (4.063Km) on RHS side and crossing at Km.10+760(RHS to LHS) respectively of Chinna Avutupalli - Gollapudi Section of NH-16 by using HDD method (Horizontal Directional Drilling).

In this regard, the IE, M/s Lion Engineering Consultants Pvt. Ltd, has reviewed the proposal and submitted vide reference 3rd cited that the checklist, drawings are found

in order as per the MoRT&H guidelines Lr.no. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016. The proposal of the agency and the comments/recommendations of AE have been examined in line with the MoRT&H Guidelines and the following are submitted.

- 1) M/s. MCGDPL, has proposed to lay 100mm dia CS-Pipe & 40mm PVC pipe line on NH-16 at Km 10+579 to Km.14+582 and crossing at Km.10+760(RHS to LHS) respectively of Chinna Avutupalli - Gollapudi Section of NH-16.
- 2) The length of crossing at Km 10+760 is 60m.
- 3) HDD Method (Horizontal Directional Drilling method) is proposed for crossing of the Highway at 1 No. Road crossing viz. Km. 10+760(RHS to LHS).
- 4) The width of RoW at Km.10+760 is 30m towards RHS and 30m towards LHS from center line of Highway.
- 5) License Deed has been submitted by M/s. MCGDPL in the prescribed format.
- 6) Construction Methodology for laying of CS-Pipe & PVC Pipe by HDD method is enclosed which is found to be in order.
- 7) Cross section showing the size of Pipe 200mm dia for HDD method and site plan showing the crossing location is enclosed.
- 8) Strip plan / Route plan for crossing of CS-Pipe & PVC Pipe, Chainage, distance of proposal pipeline for road crossings, are enclosed.
- 9) Checklist in accordance to MoRT&H Guidelines is enclosed for laying of CS-Pipe & PVC Pipe on NH land and the same is found in order.
- 10) Necessary undertakings required in accordance to MoRT&H Guidelines are also submitted by M/s MCGDPL.
- 11) As per Clause no.4 of MoRT&H guidelines Lr.no. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the consent from Petroleum and Natural Gas Regulatory Board is enclosed.
- 12) Certificate in accordance to MoRT&H Guidelines issued by the Project Director is also enclosed.
- 13) The proposal submitted by M/s MCGDPL is in conformity with as per MoRT&H guidelines vide Lr.no. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016.
- 14) Requisite Performance Bank Guarantee @ Rs.100/- per route meter along with License fee for 5 years as per MoRT&H guidelines dated 22.11.2016 will be obtained from the agency, upon approval of the above proposal.

INSPECTION REPORT

Sub: Proposal for laying of Megha gas pipe line 100mm Dia CS-Pipe & 40mm PVC pipe line along Chinna Avutupalli - Gollapudi section of NH-16 (from Km.10+579 - Km.14+582) and crossing at Km.10+760(RHS to LHS) by M/s Megha City Gas Distribution Pvt Ltd, at Vedurupavuluru Village, Gannavaram (M), Krishna District.

The access permission location was inspected by me and details are certified as below:

- i) The width of RoW from Km.10+579 to Km.14+582 (4.063 Km) on RHS side is 30m towards RHS and 30m towards LHS from center line of Highway.
- ii) The Proposed Pits for HDD method (Horizontal Directional Drilling method) are falling within the ROW.
- iii) The Proposed pipeline of 100mm Dia CS-Pipe & 40mm PVC Pipe will not disturb the Existing Crust of National Highway at the above said locations as the pipe will be laid at a depth of 1.5m below ground level in the utility corridor within the ROW.
