Section 02:8 "Dia Natural Gas Carbon Steel Gas Pipeline with OFC along the NH-43 (Near NH-43 Bamhin Road to State Boundary of Chhattisgarh) at Left Side from Ch. 210+100 to Ch. 234+550 approx. length 24.400 Km & across Ch. 160+605 & 172+550 approx. length 0.120 Km.
