It is to inform all concern that Ex. En., RUIDP, Ladnu (Rajasthan) vide letter under reference (1) above has submitted a proposal for the subjected work and PD, NHAI, PIU, Jaipur has submitted the above proposal vide letter under reference (2) for approval of the Competent Authority, Highway Administration.

2. The proposal is regarding grant of permission for laying RCC 600mm dia Sewer Pipeline along Salasar-Nagaur section of NH-58 from Km. 177.120 to 179.350 (RHS) (total length 2230m) in the state of Rajasthan by RUIDP.

Reference is invited to Executive Engineer RUIDP, Ladnu letter dated 17.01.2023 & 21.09.2023 vide which said proposal has submitted to this office for permission for laying RCC 600 MM Dia sewer pipe along with NH-58.

2. The said proposal has visited along with the representative of IE for the subjected proposal & found that:-

- (i) Undertaking, check list, drawing, etc. are as per requirement.
- (ii) Total length of sewer pipeline proposed along the NH route is 2.23 km. (ch. 177.120 to 179.350) and 200 meter (ch. 179.350) at Mega Highway link.
- (iii) Applicant shall be responsible for any damage of Project Highway including ROW and shall restore the Project Highway and ROW to its original condition.

3. Further, this office has requested EE, RUIDP, Ladnu to submit the BG and License Fee as per MoRTH guideline dated 22.11.2016. EE, RUIDP, Ladnu vide letter dated 13.06.2023 & 02.09.2023 has deposited License fee to 'BharatKosh' receipt no. 0906230009686 dated 09.06.2023 and Bank Guarantee amounting to Rs. 12.64 Lacs/- in favour of NHAI, the same has been confirmed by the Canara Bank.

4. Hence, in view of above, the proposal of permission for laying RCC 600 MM Dia sewar pipe along with NH-58 is hereby recommended for approval.
