Sub: NHAI-PIU-NSK - Widening of existing 2 lane carriage way to 4/6 lane carriageway configuration for Dhule - Pimpalgaon (Km 265.00 to Km 380.00) section of NH-3 in the State of Maharashtra - MSEDCL, Nashik's Proposal for Crossing of Underground 33 KV & 11 KV HT XLPE Electrical Cable between Km. 317.00 & Km. 318.00 (Length 250m) for Existing Nagaon Substation in Malegaon Division under MSKVY 2.0 Scheme across NH-3.

Executive Engineer, MSEDCL, Malegaon UCR-Division vide letter cited above has submitted Proposal for Crossing of Underground 33 KV HT XLPE Electrical Cable across with (Dhule-Pimpalgaon Section) of NH-3 for approval of the Competent Authority, Highway Administration.

2. From the submitted proposal, it is observed that, the Crossings Underground Electrical Line is proposed across Dhule-Pimpalgaon Section between Km. 317.00 & Km. 318.00 (Length 250m) across NH-3.
