**Sub:** NHAI-PIU-NSK-Widening of existing 2 lane carriageway to 4/6 lane divided carriageway configuration for **Vadape-Gonde** (Km 539.5-Km 440) section of NH-3 in the State of Maharashtra - **Proposal for Crossing of Overhead LILO of 400 KV D/C Bhableswar - Padghe (MH) at Boisar-II Multi Circuit Transmission Line at Km. 528+080 across NH-3.**

M/s Khavda IV C Power Trans. Ltd. vide letter cited above has submitted Proposal for Crossing of Overhead LILO of 400 KV D/C Bhableswar - Padghe (MH) at Boisar-II Multi Circuit Transmission Line at Km. 528+080 across NH-3 along with (Vadape-Gonde Section) of NH-3 for approval of the Competent Authority, Highway Administration.
