Sub: NHAI-PIU-NSK-Widening of existing 2 lane carriage way to 4/6 lane carriageway configuration for Dhule - Pimpalgaon(Km 265.00 to Km 380.00) section of NH-3 in the State of Maharashtra-Dhule Municipal Corporation, Dhule's Proposal for Laying of Water Supply Pipeline from Km. 264.600 (SVKM College) to Km. 265.000 (Hyundai Showroom Dhule) on RHS along NH-3 in the State of Maharashtra.

Commissioner & Administrator, Dhule Municipal Corporation, Dhule vide letter cited above has submitted proposal for Laying / Crossing Water Supply Pipeline along / across NH-3 for approval of the Competent Authority, Highway Administration.

- 2. From the submitted proposal, it is observed that, the Laying of Water Supply Pipeline along NH-3 (Dhule-Pimpalgaon Section) is proposed from Km. 264.600 (SVKM College) to Km. 265.000 (Hyundai Showroom, Dhule) on RHS.
