In inviting a kind reference to the above captioned letter on the cited subject, it is to furnish herewith necessary point wise compliances in respect to the observations relating to aforesaid proposal for your kind favourable consideration being smooth implementation of Govt. scheme like basic facilities of drinking water to the public under Bhawanipatna Municipality area.

2 (a): That, due to essentially required to lay the underground water supply pipe lines on NH-26 along from km.184/150 to 186/100 (K. Bandopala, WTP to Singhajharan chowk) on LHS, km.188/200 to 202/200 (Badli chowk to Hinjilibahali chowk) on LHS and across at km. 202/200 (Hinjilibahali chowk) through the PH Division Bhawanipatna under aforesaid proposal, such water supply pipelines shall be laid extreme edge of the ROW i.e. put beyond the toe line of embankment & drains as far as practicable. In this context, if any occurrence of damages notice while laying of pipelines, required restoration shall be carried out by the applicant agency, for which the S.E, PHD Bhawanipatna has already been furnished undertaking in his proposal letter no. 982 dtd.13.03.2025 (please refer thereto).

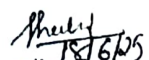
2 (b): That, keeping in view the upcoming further widening work to 4-laning under proposed Barpali-Balangir-Kesinga-Bhawanipatna-Junagarh on NH-26, now proposed to be laid pipelines within the aforesaid stretches will be needed for shift to other location as per feasibility. During further widening in that stretches, land acquisition shall be approached considering to the current available ROW. Hence, such pipelines ought to be shifted to extreme end of upcoming ROW by the water supply owing department at his own cost & risk. In this context, the S.E, PHD Bhawanipatna submitted requisite affidavit form refer to checklist condition along with their application and once again furnish their consent regarding shifting of pipelines vide his letter u/r-3, which copy is enclosed herewith for your kind ready reference.

In view of the above facts taking into consideration being essential service like basic water supply facilities for greater interest to public livelihood through the concern Department, Govt. of Odisha, it is hereby recommended to allowing them to go-ahead with their pipelining assignment to productive implementation of Govt. scheme as per your good office approval in line of Ministry's relevant guidelines vide F.No.RW/NH-33044/29/2015/S&R(R) dtd.22.11.2016 and other statutory terms & conditions, which would be strictly adhered during execution at site.

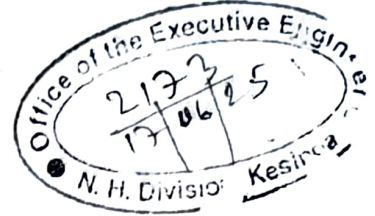

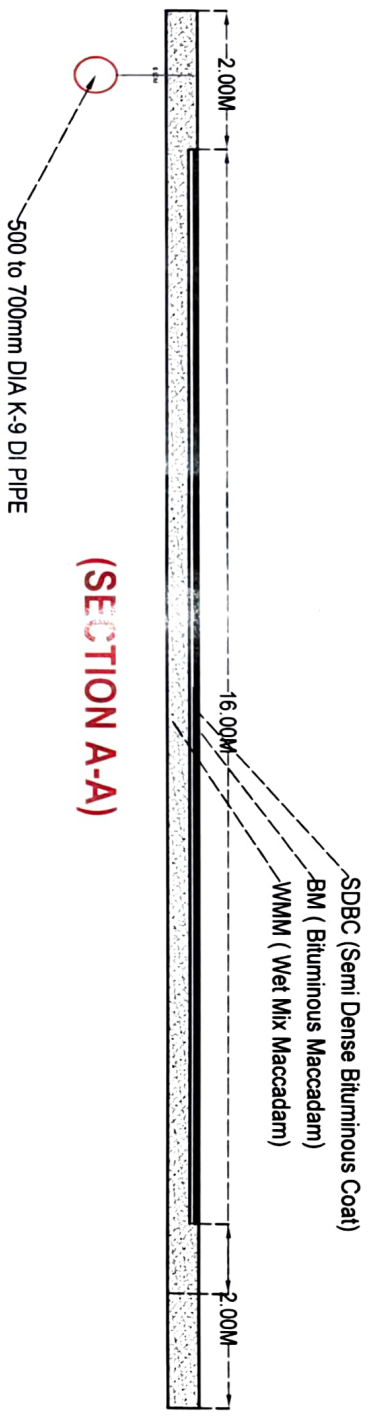
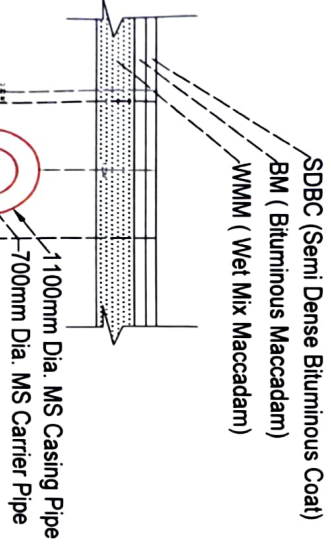
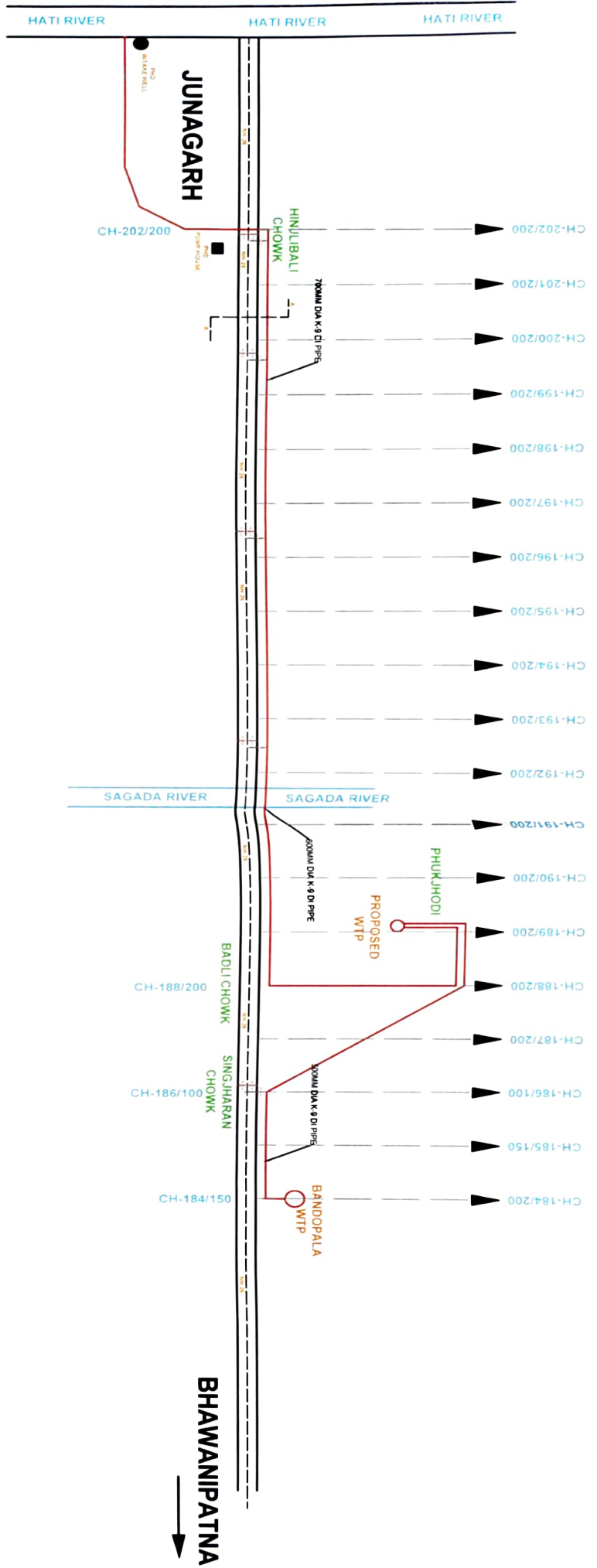

CROSSING THROUGH PIPE JACKING METHOD

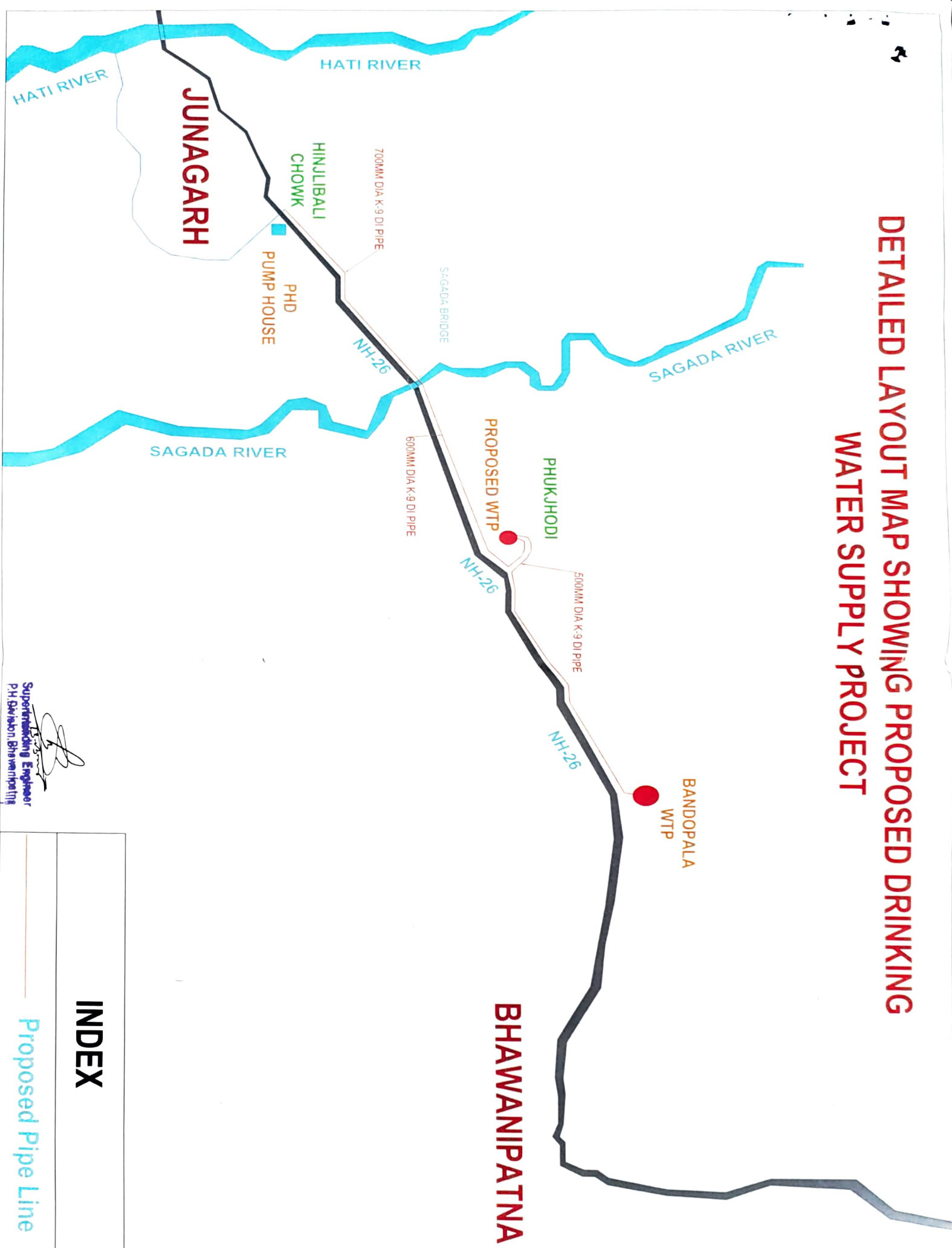
