Sub: Four lane Green Field Delhi-Amritsar-Katra Expressway from Jussur Kheri on KMP Expressway to junction with Rohtak-Panipat road NH-709 near Rukhi Paani village (km. 0+000 to km. 34+000) on Hybrid Annuity Mode under Bharatmala Pariyojana in the State of Haryana-Permission for crossing of NE-5 for creation of 220KV D/C line with conductor 0.5 sq. inch ACSR conductor from 400KV S/Stn. PGCIL Bahadurgarh to feed proposed 220KV GIS S/Stn. Pocket-B, IMT Kharkhoda by HVPNL on 50:50 cost sharing basis with HSIIDC (crossing proposal of TL no. 33 to 34 and 38 to 39 to 40) at Ch. 0+100 and loop ramps- Compliance of observations- reg.
