Invitation of Public Comments

Sub: Permission for laying of underground Gas & Oil Pipeline at NH-15 (Tinsukia Makum Bypass Road) along the NH (towards increasing chainage) from Km. Ch. 635+447 to 640+004 on LHS and from Km. Ch. 640+004 to 645+596 on RHS (total along NH: 10149 m) as well as across the NH at Km. Ch. 640+004 (total across NH: 45m)-Reg.

The GM(P), PMU-Dibrugarh vide letter no. NHIDCL/PMU-DBRG/UL/NH-15/635.447 to 645.596/2025/2798 dated 16.09.2025 has submitted a proposal along with recommendation to obtain permission for laying of 02 nos. of underground Gas & Oil Pipeline (6" Dia and 14" Dia) along NH for 10149 m (from Km. Ch. 635+447 to 640+004 on LHS and from Km. Ch. 640+004 to 645+596 on RHS) as well as across NH for 45 m at Ch. Km. 640+004 in the Tinsukia Makum Bypass Road. The applicant, Oil India Limited, had submitted their proposal to the PMU vide their letter no. CF/A-28/Gen/430/25 dated 21.08.2025. The GM(P), PMU-Dibrugarh has certified the proposal, checklist and drawings as per the extant practice.

2. The subject cited NH Section is presently being developed to a 4 Lane facility.
3. As per Ministry's circular no.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 and subsequent modifications dated 17.04.2023 and 24.04.2023, the Highway administrator will make available the subject proposal on the portal for 30 days seeking for public comments on ground of public interest.
4. In view of the above, the comments of the public are invited on the captioned proposal and the same should reach the below mentioned address till 30 (thirty) days from the date of public interest.
