Subject- Proposal of permission for laying 8" dia water pipeline along NH-51 (Botad-Limbdi-Ranpur road) from design ch 121/875 km to design ch 124/487 km LHS crossing at km 121/875 and km 124/787 to km 129/026 LHS water gravity main line from GWIL line to Kaniyad Industrial Estate in Botad district in the State of Gujarat.

The Roads and Building Department, Government of Gujarat vide letter no. NHP-13-2025-330-M dated 06.05.2025 has recommended the subject cited proposal for permission laying 8" dia water pipeline along NH-51 (Botad-Limbdi-Ranpur road) from design ch 121/875 km to design ch 124/487 km LHS crossing at km 121/875 and km 124/787 to km 129/026 LHS water gravity main line from GWIL line to Kaniyad Industrial Estate in Botad district in the State of Gujarat for approval of Highway Administration cum RO, Gandhinagar.
