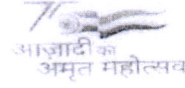


With reference to the above cited subject, it is to state that, M/s Indradhanush Gas Grid Limited (IGGL) has submitted a proposal for seeking access permission for laying 12" dia underground Natural Gas Pipeline along with OFC through ROU (Right of User) and across NH-208 for proposed Agartala Tulamura Natural Gas Pipeline (along with OFC) under NH-208. Accordingly, the same has been examined with reference to the guidelines related to grant of permission for Retail Outlet along National Highways, issued by Ministry letter no. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 and forwarded the instant proposal to NHIDCL, RO-Agartala along with the necessary documents as per the Ministry Circular dated 22.11.2016.

2. In this context, RO-Office has sought a detailed calculation sheet for the License fee & PBG as per Ministry Circular dated 22.11.2016 & 17.04.2023. Accordingly, the same has been calculated as per the Ministry Circular dated 17.04.2023 under ref. (iii) and the detailed calculation sheet for the licence fee & PBG is enclosed at Annexure - "A" & "B" respectively.

3. In view of above, it is to mention that the IGGL has uploaded the instant proposal in the MoRT&H NOC portal and the same has been forwarded to RO-Office through online mode. Moreover, it is to inform that due to some technical issue in the MoRT&H NOC portal it has been observed that the licence fee status in the applicable fee details was not displaying in the submitted proposal in online portal. In this regard, the proposal is herewith forwarded and recommended for according necessary approval from the Competent Authority. so that the licence fee and PBG can be paid accordingly for further processing of the proposal.


