Invitation of Public Comments

<u>Sub:</u> Permission for laying of proposed 18" Dia Gas Pipeline with OFC along/across NH-709AD along from design ch. 73.680 km to design ch. 75.850 km (LHS) & across at design ch. 73.680 km to develop CGD network in Bijnor district of Uttar Pradesh state - Reg.

General Manager - Projects, M/s Hindustan Petroleum Corporation Limited, Bareilly (Uttar Pradesh) has submitted the proposal for the laying of proposed 18" Dia Gas Pipeline with OFC along/across NH-709AD along from design ch. 73.680 km to design ch. 75.850 km (LHS) & across at design ch. 73.680 km to develop CGD network in Bijnor district of Uttar Pradesh state.

2. From the submitted proposal, it is seen as per the checklist, that the laying of 18" dia gas pipeline with OFC is proposed at the extreme edge of ROW of NH-709AD (Shamli-Muzaffarnagar). The section length of ROW applied is 2.23 Km. The highway configuration is 4 lane with paved shoulder and the width of ROW is around 60m.

3. Applicant has proposed the laying of 18" dia gas pipeline with OFC across/along NH-709AD through HDD and open trench method. However, permission will be given through open trench for the work executing along the Highway only with the condition that embankment of the Highway should not be damaged and laying will be done at the edge of ROW. Further, it shall be ensured that no damage is done to the Highway and the agency while laying/maintenance of pipeline shall not cause any disruption to the traffic on the Highway. If there is cross road/approach road connecting Highway and any building/structure on the route, then at that particular location laying will done only through HDD method. In case of crossings, work should be executed strictly trough HDD method.

4. As per the guidelines, issued by the Ministry vide OM no. RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016, the application shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).

5. In view of the above, comments of the public on the above application is invited to the below mentioned address, which should reach by this office within 30 days from the days from the date of publication beyond which no comments shall be entertained.
