It is to inform all concern that M/s. Torrent Gas Jaipur Pvt. Ltd., Jaipur vide letter cited under ref. 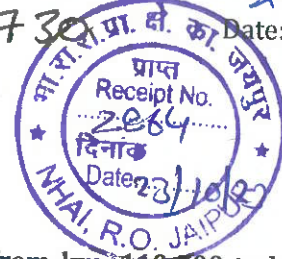
