Invitation of Public Comments

Sub: 4-laning of Madhya Pradesh/Maharashtra Border Nagpur Section of NH-7 from Km.652.000 (New Km.653.225) to Km.729:000 including construction of Kamptee - Kanhan and Nagpur Bypass and Maintenance of already 4 -laned sections from Km.14.585.000 to Km.36.600 NH-7 (Nagpur-Hyderabad Section) in the State or Maharashtra under NHDP Phase-II on DBFOT Basis- **Application for Access permission for laying of 12" dia CS & 125mm MDPE Natural Gas Pipeline along the road for development of city gas distribution network in the Geographical Area (GA-11.33) of Nagpur District from km 14.585 to km 25.200 (length 10615m) through open trench method (RHS) and 8 nos of crossings through HDD Method on Nagpur-Hyderabad section of NH-44 in the State of Maharashtra - Approval -Reg.**

It is to inform all concern that M/s HCG letter under reference (2) has submitted a proposal for the subjected work and PD, PIU-1, Nagpur has recommended the above proposal vide letter under reference (1) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by that M/s HCG for subject section of NH-44 in the State of Maharashtra is as follows:

- Laying of gas line from km 14.585 to km 25.200 (length 10615m) and 4 nos of crossings at clover leaf slip road and 4 nos of crossings at km 14.585, km 15.730, km 17.100 & km 20.940 .

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).

4. In view of the above, the comments / objections of affected public is hereby invited with reference to the Ministry's circular dated 28.01.2016 due to above transmission line on the subjected stretch. The objections / comments may be addressed to the below mentioned address within 30 days from issuance of public comments, beyond due date, no comments/ objections will be accepted.
