Invitation of Public Comments

**Sub:** Request for grant of Right of Way permission (12" Dia) Carbon Steel Pipeline along the route from Km. 516.460 to Km. 517.230 (LHS) (Route length 0.770m) on NH-19 in District - Fatehpur in the State of U.P.- reg.

The GA - Head Kanpur, M/s Indraprastha Gas Ltd., (IGL) has submitted the proposal for laying of (12" dia) Carbon Steel Pipeline through HDD method along the route from Km. 516.460 to Km. 517.230 (LHS) (Route length 770m) on NH-19 in District - Fatehpur in the State of U.P.

2. From the submitted proposal, it is seen that pipeline laying along the NH-19 is 770m. Execution work will be carried out through HDD method with a depth of 1.5m from the existing ground level.. The existing NH is 6-lane divided carriageway.

3. As per the guidelines, issued by the Ministry vide OM No.RW/NH-33044/29/ 2015/ S&R(R) dated 22.11.2016, the application shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).

4. In view of the above, comments of the public on the above application is invited to the below mentioned address, which should reach by this office within 30 days from the date of publication beyond which no comments shall be entertained.



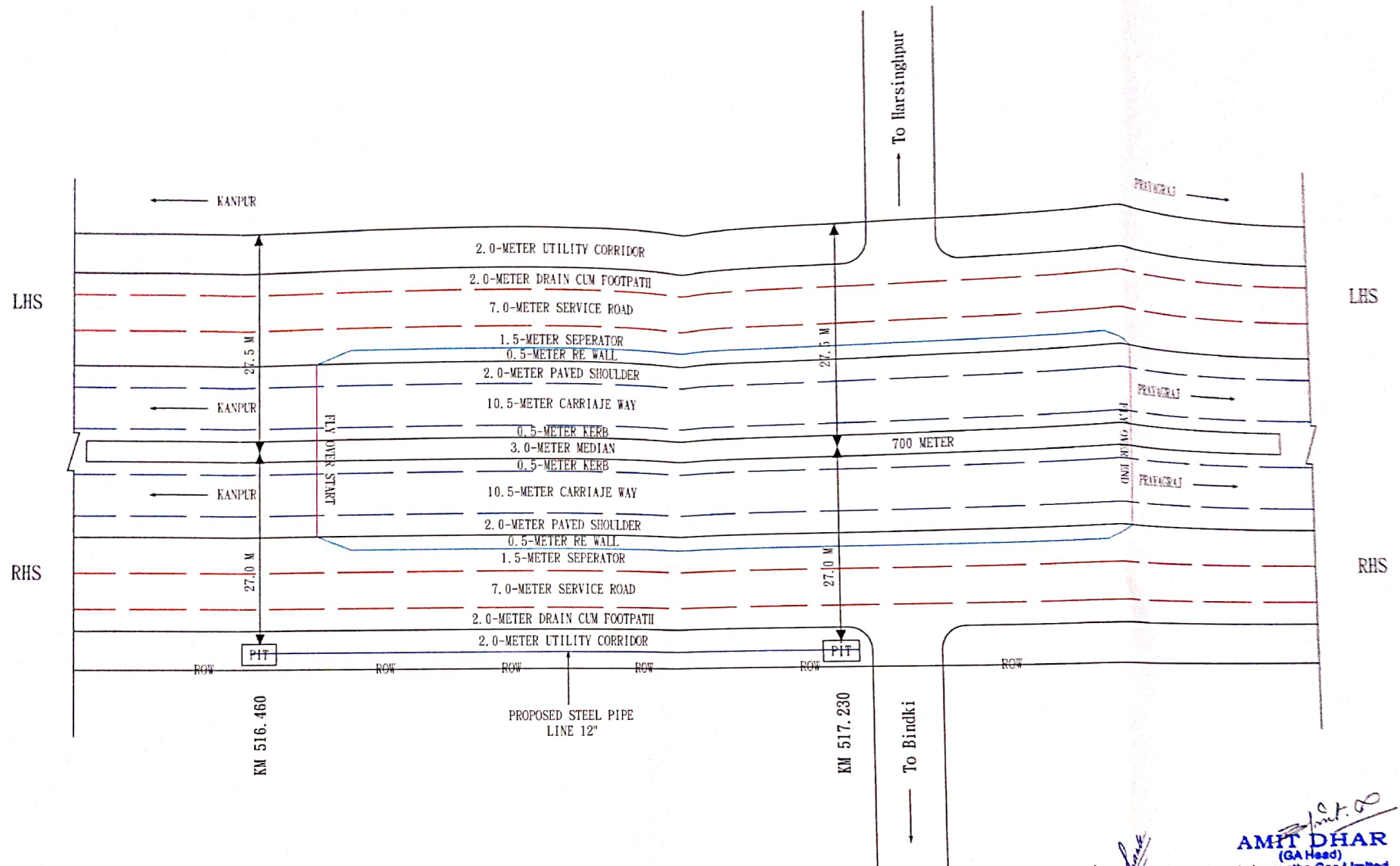
