This has reference to MoRTH, Chandigarh letter dated 11.03.2019 mentioned under ref-(1) regarding permission for laying of 8" NB Carbon Steel Gas pipeline, 125mm MDPE pipe & 50mm Duct in same trench from km. 62.900 (Jannat Dhaba) to 67,900 (opposite of old Rao Hotel) along NH-8 (48) and crossing at km. 63.900 (Metro Tyres) in the state of Haryana under Gurgaon-Kotputli-Jaipur section of NH-8.

The said proposal has examined in Consultation with Independent Engineer of Gurgaon-Kotputli-Jaipur section of NH-8 M/s Aarvee Associates, Independent Engineer of the Gurgaon-Koiputii-Jaipur project vide above referred letter dated 22.04.2019 & 01.07.2019 (copy of letters are enclosed as **Annex-1**) has informed to this office that:

"Upon examination of the physical availability of utility corridor at the desired stretch of project highway for the proposed laying of gas pipeline, it has been observed that some of the project facilities like Bus Bay, Entry/Exit ramp and Junction Improvements have not yet been completed where the said Natural gas pipeline has been proposed to be laid in the utility corridor of project highway.

After examining the case, our comments are as under:-

- i) It has been noted that the 8" NB Carbon Steel gas pipeline, MDPE Pipe & 50 mm Duct has been proposed to be laid in same trench in the Utility Corridor along the project highway from km. 62+900 to km. 67+900 on LHS (drawing enclosed).
- ii) The depth of the 8" NB Carbon Steel gas pipeline, MDPE Pipe & 50 mm Duct in HDD method has been proposed to be laid at minimum 2.4 m below the Natural ground level (drawing enclosed).
- iii) The Service Road has already been constructed.
- iv) Some stretches of the submitted proposal are falling under the Rural section from km. 62+900 to km. 67+000 in Haryana section and the PROW in the Rural section is 62.10 m and some other stretches of submitted proposal are falling in Urban section from km. 67+000 to km. 67+900 in Haryana section and the PROW in the Urban section is 53.60 m.

In addition to the above comments, the following specific comments are also given below.

- a. It has been observed that the Concessionaire is yet to take up for the construction of various project facilities in the project highway as given below.
  - From km. 64+580 to km. 64+770 LHS Bus Bay
  - From km. 64+770 to km. 65+070 LHS Junction Improvement
  - From km. 66+050 to km. 66+154 LHS Exit Ramp

As the work is yet to be taken up in the above locations, laying of the gas pipeline is not considered safe until the work is completed by the Concessionaire.

- b. Furthermore, the utility corridor is also not available in following chainages where some structures are yet to be removed and the work is also yet to be taken up by the Concessionaire.
  - From km. 64+580 to km. 64+770 LHS Bus Bay
  - From km. 64+770 to km. 65+070 LHS Junction Improvement

Hence, it would not be safe to install gas pipeline above two locations at this time when the construction is yet to be taken up which would be done after removal of structures by the Concessionaire.

3. The above said observations has been communicated to IGL vide this office above referred letter dated 23.05.2019 to submit revised drawing and method of gas pipeline laying. In compliance of that IGL vide above referred letter dated 25.05.2019 has submitted an undertaking to shift gas pipeline as per proposed ROW by NHA1, copy of the undertaking along with letter is enclosed as **Annex-2**. The submission of IGL has been forwarded to IE of the project highway for their comments. Accordingly, IE vide above referred letter dated 01.07.2019 (**Annex-3**) has submitted the following which is reproduced as under:



"Upon examination of the current submission of the applicant, it has been observed that the applicant has stated in their letter dated 25.05.2019, he has undertake that at all the non-availability of RoW locations as mentioned above where either construction work is yet to be taken up or encroachments / hindrances is there. M/S IGL will lay the gas pipeline on temporary basis along the extreme edge of currently clear RoW & will shift it whenever the additional RoW issue gets clear so that they may operate the lines until such time the additional RoW for project facilities is made available at this locations in view of the observations brought by us vide our letter 4th cited. However, the Applicant has submitted an Undertaking for shifting the gas pipeline as per proposed RoW by NHAI, whenever, the RoW gets cleared in the above three locations of Project facilities. After receiving the order from NHAI gas pipeline to be laid in the extreme edge of PROW at their own risk and cost laid and also M/s IGL has undertake to submit the bank guarantee for a period of 5 years and will continue to submit the requisite band guarantee for disputed patches unless RoW is made clear for shifting of gas pipeline & drawings for proposal for laying of gas pipeline on temporary basis in the currently available RoW at the said three locations are also attached by the Applicant.

In this connection, we have carried out a detailed site inspection alongwith the representative of the applicant (M/s IGL) and it is found that the construction of project facilities in the said locations is still not yet taken up by the Concessionaire & some existing structures are also not yet dismantled from km. 64+580 to km. 65+070 on LHS.

Keeping in view of the aforesaid points and present status of works in the site, it is informed that permission for the laying of gas pipeline of M/s IGL may be accorded on temporary basis in favour of the Applicant in view of the request and undertakings provided by them for shifting of their gas pipeline to the extreme edge of RoW at their own risk and cost laid from the date of receipt of order by NHAI after RoW clearance at this locations & bank guarantee extended for a period of 5 years and will continue to submit the requisite band guarantee for disputed patches unless RoW is made clear for shifting of gas pipeline.

We have also worked out the license fee and performance bank guarantee in favour of NHAI which are required to be obtained from M/s IGL. The amount for license for laying of 5227.10 m along NH-8 section in three different dia. of gas pipelines including one crossing has been worked to Rs. 7,21,679/- based on the prevailing circle rates for the particular villages as made available by the applicant duly considering under the category of public utilities for this case as per the guidelines of MORTH under reference 8th cited. The amount for performance bank guarantee has also been worked out. It is calculated at the rate of Rs.100/- per route meter for gas pipeline of size <= 300 mm dia/width for total length of 5165 m in three different dia. of gas pipelines & One crossing at the rate of Rs. 250/- per route meter for gas pipeline of size >300 mm and less than 1000 mm dia/width for total length of 62.10 m in NH-8 for Rs. 15,65,025/- on NH-8 initially for a period of five years (extendable if required till satisfactory completion of work) as a security to comply with the requirements of conditions as per MORT&H circulars in this regard. The amount to be deposited for payment of Performance bank guarantee is Rs. 15,65,025/- in this regard".

- 4. Accordingly, IGL vide above referred letter dated 12.09.2019 has submitted requisite performance bank guarantee of IDFC First Bank, New Delhi of amount Rs. 15,65,025/- via BG No. LOBG201011903313 valid upto 28.07.2024. Confirmation of the same is also received from Canara Bank vide above letter dated 17.09.2019 (copy of BG alongwith its confirmation is enclosed as **Annex-4**). The licence deed amount has been calculated duly considering DLC rate of agricultural land near national highway of respective village (copy of certified DLC rate is also enclosed) and assumed it a public utility provider.
- 5. In the matter of license deed, Competent Authority is hereby requested to provide the name in which favour the demand draft may be obtained from applicant for compliance of para 6 of Ministry guideline dated 22.11.2016.
- 6. The inspection of the site has been carried out on dated 07.06.2019 by NHAI and drawing and documents has been verified and are certified as correct as per the prevailing site conditions. Duly signed checklist & drawings by undersigned is enclosed with said proposal. However, as the project is still under construction phase, permission may be granted subject to fulfilling of following conditions:
  - (i) The pipeline shall be laid strictly in the utility corridor portion.
  - (ii) The gas pipelines should not be commissioned without prior permission of NHAI.
  - (iii) In future, if NHAI wants to widening of highway or due to any other purpose, applicant must to shift said gas pipeline at their own cost within 60 days positively from receiving of letter of Authority.
  - (iv) The applicant shall submit as built drawings clearly showing the laid pipeline and its distance from centre line of highway on completion of the work.
- 7. In view of the above, permission for laying of M/s IGL gas pipeline may be granted subject to fulfilment of conditions mentioned at para 6 above.

The proposal is forwarded for further necessary action please.
