**Sub:** Permission to lay Optical Fibre Cable along / across NH-52 (Old NH-211) in the following section from km 310.054 to km 313.100 for the total length of 3.045 km in the State of Maharashtra- Reg.

It is to inform all concern that M/s Jio Digital Fiber Private Limited vide letter under reference (ii) has submitted a proposal for the subjected work and PD, has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by M/s Jio Digital Fiber Private Limited is for laying Optical Fibre Cable along / across NH-52 (Old NH-211) from km 310.054 to km 313.100 for the total length of 3.045 km in the State of Maharashtra. The following work is included:

- Laying of underground Optical Fiber Cable from km 310.054 to km 313.100 (length 3.045 km) at the edge of ROW using trenching method.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).

In view of the above, the comments / objections of affected public is hereby invited with reference to the Ministry's circular dated 22.11.2016 due to above underground line on the subjected stretch.
