


Invitation of Public Comments

Sub: Proposal of permission for laying of Water Supply Pipe lines parallel to NH-53 from Km.371.700 to Km.375.500 on Chikhali – Tarsod Section of NH-53 in the State of Maharashtra by E.E., Maharashtra Jeevan Pradhikaran, Division Jalgaon– Reg.

It is to inform all concern that the E.E., Maharashtra Jeevan Pradhikaran, Division Jalgaon vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU, Jalgaon has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

- 2. The alignment proposed by that the E.E., Maharashtra Jeevan Pradhikaran, Division Jalgaon along on Chikhali Tarsod Section of NH-53 in the State of Maharashtra is as follows:
 - Laying of Water Supply Pipe Lines from Km.371.700 to Km.375.500 for Regional Rural Scheme of Area 1330 sqm through casing pipe 350mm dia D.I.K9 pipe through open trench method.
 - Laying of Pipe lines are from Indane Gas Godown to Kothali
- 3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
- 4. In view of the above, the comments / objections of affected public is hereby invited with reference to the Ministry's circular dated 22.11.2016 due to above laying of water supply pipe lines on the subjected stretch. The objections / comments may be addressed to the below mentioned address upto 09.03.2020, beyond due date, no comments/ objections will be accepted.
