

It is to inform all concern that the Executive Engineer, Amravati Irrigation Division vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU, Amravati has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

- 2. The alignment proposed by Executive Engineer, Amravati Irrigation Division for laying of Water Supply utility from Km.122.100 to Km.119.800 at village Gurudev Nagar, Tq. Tiosa, Dist. Amravati on Talegaon Amravati Section of NH-53 in the State of Maharashtra is as detailed below:
  - Two crossings at Km.122.100 and Km.119.800 near Gurudev Nagar, Tq. Tiosa, Dist. Amravati
  - It is proposed to cross 560mm water supply pipeline using HDD method and without causing any damages to highway assets.
- 3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
