In case of non submission of the cost of bid of specified amount within the specified time, the tenders shall be treated as invalid.

3. Bids must be accompanied by Original Bid security of the amount specified for the work in the table, payable at Aizawl and drawn in favour of the Chief Engineer, Highways, Mizoram PWD, Aizawl. Bid security will have to be in any one of the forms as specified in the bidding document and shall have to be valid for 45 days beyond the validity of the bid if it is in the form of Bank Guarantee.

4. Bid document shall be submit in hard bound in the office of the Chief Engineer, Highways, Mizoram PWD., Aizawl on all working days from 22<sup>nd</sup> February, 2019 to 5<sup>th</sup> March, 2019 (upto 12:00 hrs).

5. Cost of Bid Document and Bid Security in Original shall be submitted to the office of the undersigned starting from **22<sup>nd</sup> February**, **2019 up to 7 days** after the period of submission of bid document either by registered post/ Speed post or by hand. Only those applications will be entertained whose cost of bid and bid security is received within the specified time. The Chief Engineer, Highways, Mizoram PWD., Aizawl will not be held responsible for the postal delay, if any, in the delivery of the Bid Security or non receipt of the same. **50% of the cost of document will be exempted for Scheduled tribe.**

8. The bidders are requested to submit relevant documents only as per bid criteria pertaining to preparation of technical bid.
