It is to inform all concern that M/s. 2. The proposal is regarding permission for laying 8" dia steel natural Gas pipeline parallel to NH-27 across to National Highway -27 (Pindwara-Udaipur) from NH- Ch. 695/531 Km. to 692/521 Km. (L=3/010 Km.) near village Kantal along the pipeline route in Sirohi District by M/s. Gujarat Gas Ltd. in the state of Rajasthan.

Sir,

With reference to the subject cited above, it is to submit that as per NHAI HQ circular dated 06.01.2020, the Project Director is the 'proposing Authority' for "Grant of Right to Access to the Highway, private properties, Rest Area complexes and such other facilities" and 'Competent Authority' is Regional Officers of NHAI.

In the instant case, the subjected proposal of M/s. Gujarat Gas Ltd was received in this office through MoRTH, Regional Office, Jaipur vide letter cited (i) above. The proposal has been examined by Supervision Consultant M/s. S.A. Infrastructure and submitted the report vide letter No. SA/SC/O&M/Udai/2019-20/43 dated 10.07.2020 along with lease rent calculation.

Accordingly, this office vide letter cited (iv) above (copy enclosed) has requested to the applicant for Depositing lease amount of Rs. 57,531/- through Bharatkosh Portal ([www.Bharatkosh.gov.in](http://www.Bharatkosh.gov.in)) and submit performance Bank Guarantee amounting to Rs. 3,01,000/- (3100 m x Rs. 100/-) valid for a period of one year in favour of Project Director, NHAI, Udaipur.

Subsequently, M/s. Gujarat Gas Ltd has submitted the following:

- Licensee fee:** Proof of deposition of lease amount of Rs. 57,531/- through Bharatkosh.gov.in vide transaction Ref. No. 0709200005074 dated 07.09.2020.
- Bank Guarantee:** Original Bank Guarantee No. 0810IGP200023134 dated 28.09.2020 amounting to Rs. 3,01,000/- valid upto 27.09.2022 issued by Kotak Mahindra Bank Ltd, Ahmedabad towards execution of subjected Gas pipeline in a length of 3.010 Km in favour of Project Director, NHAI, Udaipur (copy enclosed). The confirmation has been received from their Mumbai branch vide letter dated 28.09.2020 (received on email dt. 3.11.2020).

The proposal has been examined by Supervision Consultant as well as this office in line with MoRTH Circular No. RW/NH-33044/29/2015/S&R (R) dated 22.11.2016 and MoRTH RO letter No. RW/JAI/RJ/PS/2017/UTILITY/GENL dated 16.03.2017 and found in order.

In view of the above, it is recommended to accord necessary permission to M/s. Gujarat Gas Ltd against their aforementioned proposal.



The permission for laying of Gas Pipe Line shall be considered for approval / rejection based on the Ministry Circulars mentioned as above,


Carrying of sewage/ gas pipelines on highway Bridges shall not be permitted as Furmes/ gases pipes can accelerate the process of corrosion or may cause explosions, thus, being much more injurious than leakage of water.

Services are not being allowed indiscriminately on the parapet/ any part of the bridges, Safety of the bridges has to be kept in view while permitting various services along bridge.



