**Invitation of Public Comments**

Sub: NHAI, RO Chennai - PIU - Coimbatore - Implementation of 'Bharatmala Pariyojana' Phase - I - Assigning 3 Project Stretches / NHs to Tamil Nadu State NH-wing - "Thoppur - Mettur - Bhavani - Erode - NH-544 - Updation of Detailed Project Report (DPR) prepared by Tamil Nadu Road Sector Project (TNRSP) for NHAI - Salem (NH) Circle - Gobichettipalayam (NH) Division - Bhavani (NH) Sub Division - Thoppur - Mettur - Bhavani - Erode Road - (NH-544H) - Submitting - Proposal of Shri.K.S.Selvaraj S/o Sembagoundar for laying of underground Agricultural pipeline from Km 61/630 to Km 62/120 (LHS) and across the road at Km 61/630 in the Project Highway Thoppur - Mettur - Bhavani - Erode section of NH-544H in the limit of National Highways - Reg.

1. The proposal is requesting permission for laying of underground Agricultural pipeline of 150mm dia PVC pipe length of 490.00m along the road from Km 61/630 to Km 62/120 (LHS) by open Trench method, and 300 mm dia MS casing for 150mm PVC pipe length of 38.40m across the road at Km 61/630 for laying at minimum 1.65m depth below the ground level by HDD method in the road of NH-544H (Boring Method) in the Project highway Thoppur - Mettur - Bhavani - Erode in the State of Tamil Nadu. The available width of ROW varies from 26m to 43.5 m.

2. Shri.K.S.Selvaraj S/o Sembagoundar has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, If NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 60 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.

3. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R (R) dated 22.11.2016, the proposal submitted by Shri. Shri.K.S.Selvaraj S/o Sembagoundar will be made available for 30 days seeking public comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
