It is to inform all concern that M/s GAIL (India) Limited vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU-2, Nagpur has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by M/s GAIL is for crossing of 18" dia Gas alongwith 40mm OFC across National Highways 47 at km 40+489, village Pardi Taluka Saoner Dist. Nagpur. The following work is included:

Crossing of Gas pipeline 18" dia at Ch. 40+489 on National Highway No. 47 through HDD Method.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
