It is to inform all concern that the Ex. En PHED, City Div. Bhilwara vide letter under reference (1) has submitted a proposal for the subjected work and PD, NHAI, PIU, Chittorgarh has submitted the above proposal vide letter under reference (2) for approval of the Competent Authority, Highway Administration.

Sir,

A proposal for laying utility water pipelines from km 105+650 to km 106+300 (BHS) along the road for village Agarpura, Distt. Bhilwara in the state of Rajasthan is submitted by the Executive Engineer PHED City Division, Bhilwara vide letter under reference (1).

2] The proposal was sent to the Authority Engineer M/s. TPF Getinsa-Eurostudious in association with Sterling Indotech Pvt. Ltd. for its examination in light of MoRTH's Guidelines RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 and subsequently, AE vide letter under reference (3) conveyed their comments with recommendation for approval.

3] The proposal has been examined at site by PIU Chittorgarh. The checklist, undertaking as per MORTH Guideline dated 22.11.2016 is appended with the proposal.

4] The license fee is not applicable as per the Circular of GoR Revenue Department issued on 28.04.2016 wherein as per para (1), the land under utility corridor for subterranean projects of state shall be made available free of cost by NHAI. Further the Bank Guarantee amounting to Rs. 1,30,000/- in favor of National Highways Authority of India, PIU Chittorgarh shall be asked prior to signing of the agreement and grant of provisional NOC.

In view of the above, the proposal for laying utility water pipelines from km 105+650 to km 106+300 (BHS) along the road for village Agarpura, Distt. Bhilwara in the state of Rajasthan, is herewith recommended for approval of the Competent Authority.






