Invitation of Public Comments

Sub: NHAI, RO, Chennai - PIU, Krishnagiri - M/s. Jio digital Fibre Pvt. Ltd., - permission for laying of Underground OFC on Hosur - Krishnagiri section of NH-44 (Old NH-7) along and crossing for a total length of 6730.99 meters -Reg

The proposal is regarding laying of Optical Fibre cable along Hosur to Krishnagiri Section of NH-44(Old NH-7) from Km 33/700 to Km 34/350 (RHS), Km 36/900 to Km 38/000(RHS), Km 39/850 to Km 40/200(LHS), Km 41/000 to Km 41/300(RHS), Km 41/500 to Km 41/600(RHS), Km 43/450 to Km 43/600(RHS), Km 44/450 to Km 44/500 (RHS), Km 45/350 to Km 45/400(RHS), Km 45/630 to Km 46/000 (RHS), Km 45/630 to Km 46/000(LHS), Km 55/000 to Km 55/100(RHS), Km 57/860 to Km 58/000 (RHS), Km 59/700 to Km 59/720 (RHS), Km 61/000 to Km 61/850 (RHS), Km 66/000 to Km 66/100(RHS), Km 70/350 to Km 70/400(RHS) for a length of 4750m. Across the road Km 33/700, Km 34/350, Km 36/900, Km 40/600, Km 41/500, Km 42/150, Km 43/100, Km 43/450, Km 44/450, Km 44/500, Km 45/350, Km 45/630, Km 52/080, Km 55/000, Km 57/140, Km 57/860, Km 58/000, Km 59/700, Km 59/720, Km 61/000, Km 66/000, Km 66/100, Km 70/350, Km 70/400, Km 77/860, Km 83/560, Km 86/200 for a total length of 1923.99m and Proposed pre-fabricated Man Hole at 57 locations (1m Dia) in a Total Length of 6730.99 meters by M/s. Jio digital Fibre Pvt Ltd and submitted to this office by the PD, NHAI, Krishnagiri vide letters No. NHAI/11013/OFC/2020/PIU-K'giri/1300 dated 14.10.2020.

- 2. The available width of ROW Varies from 20.30m to 41.10m and from 20.60m to 46 m on LHS and RHS respectively. It is proposed to lay at edge of RoW at extreme distance from centreline of the main carriageway.
- 3. M/s. Jio Digital Fibre Private Limited, Chennai has proposed to lay OFC along the road by open trench method and across the road and intersection locations by HDD method. It is proposed to lay 20mm dia OFC Cable (2 nos.) along the road by open trench method encased in 40mm dia PLB pipe duly keeping the top of the casing at 1.65 m below the top of sub grade level. Further, the applicant has proposed to lay the 20mm OFC cable (2 nos) across NH by HDD method, encased in 40mm PLB pipe, which in turn encased in 100mm HDPE pipe duly keeping the top of the casing pipe at a depth of 1.65m below the top of sub grade level.

Jio Digital Fibre Private Limited, Chennai has furnished an undertaking to accept any claims raised by the Concessionaire if any and the same will be paid by them and furnished undertaking not to damage other utility, if damaged, then to pay the losses either to NHAI or to the concerned agency. Further, the applicant has furnished undertaking that they will adopt HDD method wherever, the available width of ROW is less than 15m.
- 5. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016, the proposal submitted by M/s. Jio Digital Fibre Private Limited, Chennai will be made available for 30 days seeking public comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
