Invitation of Public Comments

Sub: NHAI RO Chennai – PIU Chennai – Proposal for granting of NOC for proposed construction of access to the private property of Shri. Saidiah Thondapu, Chennai from Km 6/707 to Km 6/800 on RHS in Survey No. 41/1, 2B & 3C of Thiruneermalai village (Town Panchayat Limit), Alandur Taluk, Kancheepuram District of Chennai Bypass – 3rd Extension of Time – Approval requested – Reg.

The proposal is regarding issue of 3rd Extension of Time for granting of NOC for proposed construction of access to the private property of Shri. Saidiah Thondapu, Chennai from Km 6/707 to Km 6/800 on RHS in Survey No. 41/1, 2B & 3C of Thiruneermalai village (Town Panchayat Limit), Alandur Taluk, Kancheepuram District of Chennai Bypass submitted by PD, NHAI, Chennai vide letter No. NHAI/ 18011/ 10.28/ 09/ PIU.Chennai/ 2221 dated 09.11.2020.

2. RO, MoRTH, Chennai vide letter No. RW-MD/TN/CBP/PP/87/2017-18 dated 23.01.2018 had accorded In-principle approval for construction of access to the private property of Shri. Saidiah Thondapu, Chennai from Km 6/707 to Km 6/800 on. RHS in Survey No. 41/1, 2B & 3C of Thiruneermalai village (Town Panchayat Limit), Alandur Taluk, Kancheepuram District of Chennai Bypass within six months of issue of provisional NOC. Also it was mentioned that in case, the construction is not done in one year the provisional approval shall be deemed to be cancelled unless got renewed.

3. Further RO, MoRTH, Chennai vide letter RW-MD/TN/CBP/PP/87/2017-18 dated 30.04.2019 accorded approval for extension of provisional NOC upto 23.01.2019 with the condition that in case proposal for grant of final permission and licence deed is not received within 01.08.2019, the proposal is deemed to be cancelled and Provisional NOC granted by MoRT&H is treated as withdrawn.

4. Based on the request of Shri. Saidiah Thondapu, Chennai vide letter date 21.01.2020, RO, NHAI, Chennai vide NHAI/11019/17/RO Chennai/1484 dt. 04.05.2020 has granted 2nd extension for further one year i.e. from 23.01.2019 to 22.01.2020, so as to complete the balance works.

Now, the Owner of Private Property, Mr.Saidiah Thondapu, Chennai vide 5. letter dated 07.11.2020 has requested 3rd extension for further one year upto 21.01.2022 stating that the work of construction could not be completed within the stipulated time due to outbreak of COVID -19 and the same has been recommended PD, Chennai vide NHAI/ 18011/ 10.28/ 09/ PIU.Chennai/ 2221 dated

As per Ministry's letter No. RW-NH-33023/19/99-DO-III dated 01.12.2014 6. "the highway administration may grant one time extension upto one year for the period of construction on genuine grounds with proper justification for the delay. As already mentioned above one year extension after In-principle approval was already accorded by RO, MORTH Chennai. However, guidelines do not cover for further extensions beyond the expiry of one time extension of one year period. As such, issue of further extension beyond already granted extensions for construction of approaches to the retail outlet / service road will tantamount to relaxation.
