Sub: NHAI, RO Chennai – PIU, Chennai- Proposal for laying of water pipeline across the road at Km 10/940 by Open Trench Method in Koyambedu to Maduravoyal section of NH-4 - Reg.

The proposal is regarding permission sought by the Executive Engineer(P)-IV, CMWSSB, Chennai seeking permission for laying of water pipeline across the road at Km 10/940 by Open Trench Method in Koyambedu to Maduravoyal section of NH-4 in the State of Tamil Nadu submitted to this office by the PD, NHAI, Chennai vide letter No. NHAI/11013/4/2018/PIU.Chennai/1667 dt. 04.09.2020.

2. Executive Engineer(P)-IV, CMWSSB, Chennai has proposed for laying of water pipeline across the road at Km 10/940 by Open Trench Method. The proposal is for laying of 500 MS pipe with in a encasing MS pipe of 1000 mm dia. The top of the encasing pipe is proposed at a depth of 1.2m from top of subgrade.

3. The submitted proposal is in conformity with Ministry's latest guidelines, regarding accommodation of public and industrial utility services along and across National Highways, issued vide letter dated 22.11.2016.

4. Superintending Engineer (Construction), CMWSS Board, Chennai has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/27/2005-S&R dt.21.09.2010 as when asked by NHAI.

5. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by the Executive Engineer, TWAD Board, RWS Division, Karur will be made available for 30 days for public comments/objections and the comments are to be furnished within 30 days from the day of closure.
