The NHAI vide reference 3<sup>rd</sup> cited, has requested to complete the construction of Acceleration /Deceleration lanes and obtain completion certificate for issuing of

license deed from the Highway Administration within stipulated time period as per MoRTH Circular No.RW/NH-33023/19/99\*DO-III dtd: 24.07.2013.

In this connection it is to submit that the TSIIIC has taken up the Construction of access road work which is in progress. However, the work is delayed due to the following reasons:

**A) SHIFTING of ELECTRICAL POLES:**

- 1) TSIIIC has taken up the shifting of 33 & 11 KV lines work duly paying the necessary charges towards shifting of lines based on the sanction accorded by TSSPDCL vide references 4<sup>th</sup> & 5<sup>th</sup> cited, but as per the site condition it was necessitated to erect certain poles in the premises of the Textile park of Malkapur which are falling in subject road alignment. TSIIIC vide reference 6<sup>th</sup> cited has requested the Textile Department to accord necessary permission for erecting the Electrical poles in their premises.
- 2) The Textile Department have accorded permission vide reference 7<sup>th</sup> cited to shift the existing 33 & 11 KV lines along the compound wall inside the Textile park Malkapur so as to take up the formation of subject service road work duly furnishing the undertaking to Textile Department by TSIIIC. Accordingly vide reference 8<sup>th</sup> cited, TSIIIC has submitted the undertaking.

**B) TRANSLOCATION OF PLANTS:**

- 1) TSIIIC has requested to HMDA vide reference 9th cited, to accord permission for taking up the translocation of Plants as certain plants are in the alignment of subject service road. The HMDA vide reference 10th cited has requested to deposit fee towards translocation charges and permitted to take up the translocation of trees.

**C) REPAIR WORKS FOR DAMAGED PIPELINES AND FIBRE OPTIC CABLES:**



Attention is invited to the subject & references, wherein it was requested to accord permission for translocation of plants to be taken up as that area is falling in the alignment of service road to be taken up by TSIIC for providing connectivity to the National Highway -65 to the approach road for Industrial Park (MSME) through the proposed service road at Dandumalkapur (V), Choutuppal (M), Yadadri Bhuvanagiri District.

The matter has been examined and as per the report of the Forest Manager-I, Urban Forestry, HMDA, (142) plants will be affected due to approach along service road and the same have to be translocated to other locations. The cost for translocation of one such small tree is Rs.2780/- and the total cost arrived is Rs.3,94,760/- (Rs.2780/- x 142).

Please refer to your letter No. NHAI/PIU-HYD/Hyd-Vij/Access/2018/110 dated 01.02.2019 submitting there with a proposal on the above mentioned subject.


2. The proposal has been broadly examined on your recommendations; the proposal is accepted "in-principle" by Highway Administration (HA)/RO, Hyderabad subject to the following conditions and the corrections made on the proposed layout plan:

- (i) The issue of final formal permission including issuance of signed license deed would be subject to the certification by the Project Director, PIU, NHAI, Hyderabad that the construction has been carried out in compliance with the provisions approved by Highway Administration. Hence, it is directed to issue the completion certificate after construction of access road as per proposed corrected layout plan duly endorsing a copy to this office along with fresh license deed for issue of final permission.
- (ii) The validity of the in-principle NOC and the subsequent final approval shall be governed by Para 11 of the Ministry's circular no. RW-NH-33023/19/99-DO-III dt.24.07.2013, i.e., the Oil-company/Owner should construct the fuel-station/Private Property along with its access as per approved drawings at their own cost within 6 months of the issue of this provisional NOC. After the construction as per approved drawings and to the satisfaction of the Highway Administration, the final approval will be issued within 30 days of the receipt of communication from the applicant about the completion of construction work and license deed will be signed by the Competent Authority (i.e. Highway Administration). In case, the construction is not done in one year (1 year), the provisional approval shall be deemed to be cancelled, unless renewed by the Highway Administration.
- (iii) The fresh license deed (duly indicating chainages of NH) in two originals drawn on new stamp paper as per Ministry's standard norms and duly signed by authorized signatory may also be furnished at the time of issue of final approval. However, the Private property shall not take access before issue of final permission by the Competent Authority.

- (iv) There should be sufficient parking inside so that there is no overflow of vehicles on approach roads.
- (v) The applicant shall install all the requisite road signs as per IRC: 67 & provide road markings as per IRC: 35 in accordance with the Ministry's guidelines and to the satisfaction of the Project Director, PIU, NHAI, Hyderabad.
- (vi) The applicant shall arrange all the clearances including forest clearance required for constructing the proposed access as per approved drawing himself. The applicant shall also arrange for shifting of utilities if required at his own cost as per the direction of the concerned department.
3. It is requested, that requisite fee of Rs.1,50,000/- (Rupees One lakhs fifty thousand only) under title of access permission fees of fuel stations on Bharatkosh to PAO- "002193 - Regional Pay & Accounts Officer (NH), Hyderabad" and DDO- "203942- Superintending Engineer" by the licensee to the Government of India in consideration of agreement for the land for which license is issued as indicated in Para-5 of Ministry's circular no. RW-NH-33023/19/99-DO-III dated 24.07.2013 may be deposited within 30 days from the issue of this letter, failing which the "in-principle" approval now issued is deemed to be cancelled. The license deed shall be executed only after the deposit of the said fee in Central Revenue Major Head 1054 and after completion of construction as per approved drawings and to the satisfaction of the Highway Administration.
4. Notwithstanding anything in the above paras, the provisional NOC issued shall stand to be cancelled under the following circumstances:
- (i) If any document/information furnished by the applicant proves to be false or if the applicant is found to have will fully suppressed any information.
- (ii) Any breach of the condition imposed by the Highway Administration or the officer authorized by the Administration on his behalf.
- (iii) If at any later stage, any dispute arises in respect of the ownership of the land on which the fuel station is located or regarding the permission for change of land use.
5. This issue with the approval of the Regional Officer (MoRT&H), Hyderabad.
