Sir,

In inviting your kind attention towards the subject matter, the permission for laying of water supply pipe line laid from intake well along NH- 5A at Km 72 + 200 to Km 73+ 432 on right side and across the NH at Km 73+ 432 was communicated vide this office letter No 2698 dated 02.06.2007 in the favour of IOCL, Paradip Refinery. Further, an Agreement for the subject work was signed between PD & CFO (PPRCL) and Project Manager, IOCL, Paradip Refinery for the period of 5 Years.

Further, the agreement of the above work was expired after completion of 5 years. The applicant was not applied any extension during the period of contract. However as per the provision under Clause No. (xi) of agreement signed, "The permission may not be renewed after the expiry of the Agreement".

Again, IDCO, Bhubaneswar vide their letter No. 826 dated 29.07.2021 has requested RO, Odisha office to issuance of NoC in favour of IDCO because M/s IOCL, Paradip is handing over this asset to IDCO, Bhubaneswar.

In this context, this office vide letter no. 1138 dt. 14.09.2021 has requested M/s IOCL, Paradip to submit the details of the above agreement including the extension of contract if any.

In this connection, M/s IOCL, Paradip has vide their letter no. 4 dt. 29.09.2021 has submitted that no record for extension above permission is available in their office. Accordingly, this office again requested to M/s IOCL, Paradip to apply the extension and deposit the licence fee so that this office may recommend the proposal to Competent Authority for regularization of the above permission as well as the proposal for NoC in favour of IDCO, Bhubaneswar.

In the reply of the above, M/s IOCL, Paradip has informed that the above pipeline was defunct after expiry of the above permission. Hence, they did not apply any extension for subject permission so relax the levy of licence fee and issue the NoC in favour of IDCO, Bhubaneswar.

In view of the above fact, the proposal for the issue of the NoC in favour of IDCO, Bhubaneswar for subject permission is herewith submitted for taking necessary action by Competent Authority.
