It is to inform all concern that M/s GAIL (India) Limited vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU, Yavatmal has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

- 2. The alignment proposed by M/s GAIL is for crossing of 24" dia Gas pipeline alongwith OFC Cable across National Highway-361 at km. 511.550 NH Ch. falling enroute Mumbai to Nagpur Pipeline in Wardha District. The following work is included:
 - Crossing of Gas pipeline 24" dia at Ch. 511.550 on National Highway No. 361 through HDD Method.
- 3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
