Proposal for ROW permission for laying of Pipeline Along & Across of NH-27 for "Construction of works of water supply production and distribution network, improvements with house service connection for nonrevenue water reduction and continuous water supply and providing sewer network with house connections, and construction of sewer treatment plant and all allied works and operation services of the entire system for 10 years at Abu Road" (RSTDIP/ABR/01) in the state of Rajasthan.
