This has reference to M/s FPI Auto Parts India Pvt. Ltd. above referred letter dated 15.11.2021 & 18.01.2023 regarding Proposal for grant of permission for laying of 33 KV Electrical cable along NH-08 (New NH-48) from Route-1 Ch. 107.955 to Ch. 111.180 (LHS) on NH-08 (New NH-48) of Delhi-Jaipur road at Village-Shahjahanpur District Alwar in the state of Rajasthan under Gurgaon-Jaipur section of NH-08.

2. The proposal has been examined in this office and recommended the same to RO Jaipur vide this office letter dated 13.02.2023 for the approval of the Competent Authority. RO Jaipur vide their letter dated 03.03.2023 has raised some observations, the same has been forwarded to IE vide this office email dated 21.03.2023. IE vide letter dated 21.03.2023 has submitted that "a joint site inspection has been done as per present site condition and found that the space is available for the proposed utility within the utility corridor".

3. Further, it is to inform that calculation of license Fee and Bank Guarantee has been calculated considering on the industrial purpose and charges deposited by the applicant in full manner instead of 33% of public utility. IE has also confirmed that the space is available for the proposed utility within the utility corridor.

4. In view of above, the said proposal has been recommended to grant permission for laying of 33 KV Electrical cable along NH-08 (New NH-48) from route-1 Ch. 107.955 to Ch. 111.180 (LHS) on NH-08 (New NH-48) of Delhi-Jaipur road at Village-Shahjahanpur District Alwar in the state of Rajasthan.
