

To meet the growing demand of Petroleum products in state of Uttar Pradesh (UP), Bharat Petroleum Corporation Limited (BPCL), a Government of India undertaking under the aegis of Ministry of Petroleum & Natural Gas (MOPNG), envisages laying of 18 inch diameter, approximately 356 KM long, API 5L grade cross-country pipeline for the movement of Motor Spirit (MS)/ High Speed Diesel (HSD)/ Superior Kerosene Oil (SKO)/ Aviation Turbine Fuel (ATF) from BPCL, Bina Dispatch Terminal situated at BORL, Bina to existing BPCL POL Depot at Bhauti, Panki (Kanpur). The pipeline shall be laid with two number dedicated OFC cables for pipeline safety and supervision during its operation.

The proposed is being laid for the transportation of the finished petroleum products as enumerated in above para, which is of national importance and is a crucial link for evacuation of the petroleum products from our Refinery at Bina. En-route the pipeline will pass through two districts of M.P. i.e. Sagar & Tikamgarh and five districts of U.P. i.e. Lalitpur, Jhansi, Jalaun, Kanpur Dehat and Kanpur Nagar.

We are pleased to inform you that we have received a Grant of Authorization for the subject pipeline on 21<sup>st</sup> December, 2018 from the Petroleum and Natural Gas Regulatory Board (PNGRB). A copy of Grant of Authorization is attached herewith as **Annexure-1**.
