Sub: Improvement of NH-53 passing through Jalgaon City to four lanes along with construction of VUPs and PUP in the State of Maharashtra to be executed on EPC Mode – Grant permission for crossing and laying of Sewage pipeline of Jalgaon Municipal Corporation across National Highway-06 in the State of Maharashtra – Reg.

It is to inform all concern that Jalgaon City Municipal Corporation Jalgaon vide letter under dated reference (2) has submitted a proposal for the subjected work and PD PIU, Jalgaon has recommended the above proposal vide letter under reference (1) or approval of the Competent Authority / Highway Administrator.

- 2. The alignment proposed by Jalgaon City Municipal Corporation Jalgaon is along the improvement of Jalgoan city section of NH-6 (New NH-53) in the State of Maharashtra as follows:
 - Laying of (500mm dia. M.S. Pipe) pipeline along Highway from Ch. 1.850 to km 2.900 at the extreme edge of RoW using open trench method at 1.2m below ground level.
 - Crossing at Ch. 1.340, Ch. 1.890, Ch. 2.600, Ch. 2.680, Ch. 2.830, Ch. 2.900 & Ch. 3.520 through HDD method.
- 3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
- 4. In view of the above, the comments / objections of affected public is hereby invited with reference to the Ministry's circular dated 22.11.2016 due to above underground line on the subjected stretch.
