

Operation & Maintenance period of Six Laning of Samakhiali-Gandhidham section NH-8A SUB: from Km 306.000 to Km 362.160 in the state of Gujarat to be executed as BOT (Toll) on DBFOT under NHDP Phase-V. Reg. Proposal seeking ROW permission for laying of 66kV 630Sqmm (3+1) U/G Cable line (Route length 9.5 km) for proposed 66kV Ratnal SS to existing 66kV Dhaneti SS with ACSR Panther conductor line partly on D/C tower with ACSR Panther conductor & partly with 660 kV 630 Sq. mm (3+1) U/G cable parallel to NH-341 at Km 35+910 to Km 37+680, Near Village-Old Ratnal, Tal-Anjar, Dist-Kutch in the state of Gujarat.
