**Sub:** NHAI, PIU, Coimbatore - Request for permission to lay underground Optical Fibre Cable (OFC) on Chengapalli to Walayar Section of Salem - Cochin Road between km 130/205 to km 130/890 (LHS); km 135/420 to km 135/610 (RHS), km 135/610 to km 135/860 (LHS), km 138/210 to km 139/615 (LHS), km 180/112 to km 181/000 (LHS), km 181/000 (LHS), km 182/000 to km 182/302 (LHS) and across @ km 135/610, km 138/210, km 139/615, km 180/112 of Chengapalli to Walayar Section of NH-544- Reg.

1. The proposal is regarding permission for laying Optical Fibre Cable (OFC) on the above said project chainages by Open trench / HDD method for a length of 4960 m by M/s.Jio Digital Fibre Private Limited, Mylapore, Chennai.
2. M/s.Jio Digital Fibre Pvt Limited, Chennai has furnished an undertaking to accept any claims raised by the Authority, if any and the same will be paid by them and also furnished undertaking not to damage other utility, if damaged, then to pay the losses either to NHAI or to the concerned agency.
