**SUB:** Six Laning of Mota Chiloda to Nana Chiloda from existing Km 494+410 to existing Km 509+550 of NH-8 in the state of Gujarat on EPC Mode under NHDP Phase-V (Package-VII).  
- Proposal seeking ROW Permission for laying of 110mm PVC Pipeline along NH-48 from Km 549+884 to Km 551+280 (LHS) and across at Km 551+280 at Gandhinagar District on Mota Chiloda to Nana Chiloda section of NH-48 in the state of Gujarat.


