Project Director, NHAI, PIU-Hazaribagh vide letter no 95 dated 08.05.2025 and letter no 177 dated 12.06.2025 has submitted the proposal for klaying of pipe line in Chouparan (north, South & Barhi Part) Rural Water Supply Scheme (RRWS) from Km 0+000 to Km 27+500 in section of NH-33 (Barhi-koderma) National Highway for further necessary action.

As per Ministry circular issued vide OM no. RW/NH/33044/29/2015/S&R(R) dated 22.11.2016, the Highway Administration shall make available the proposal for granting license for use of National Highway land for laying utility service for public comments for 30 days on ground of public interest.

RO-Ranchi vide letter no-1120 dated 26.06.2025 has directed to invite Comments of general public for subject captioned proposal on "What's New" of NHAI website & Ministry's web site for 30 days from the date of uploading.

Sir,

Please refer to your letter dated 12.06.2025 (ref.i) & letter dated 08.05.2025 (ref.ii) vide which the proposal of Executive Engineer. DWSD, Hazaribagh for laying of pipeline in Chauparan (North, South and Barhi Part) Rural Water Supply Scheme (RRWS) from Ch. Km. 0+000 to Ch. Km. 27+500 in section of NH-33 (Barhi-Hazaribagh) has been submitted after compliance of raised observations with recommendation for approval of 'NOC'.

- 2. The submitted proposal has been examined as per the instructions contained in the Ministry's Circular No. RW/NH-33023/29/2015/S&R(R) dated 22.11.2016, MORTH Policy Guideline dated 24.04.2023 and following is observed:
- (i) The Checklist, Details of revised License fee found to be incorrect. The license fee has been corrected based on recommendation by PIU (Copy attached). Correct checklist & duly signed revised calculation details of license fee shall be submitted.
- (ii) In the submitted utility strip plan water pipeline NH-31 crossing No. 2 at Ch. Km.1+940 & laying from Ch. Km.1+940 to Ch. Km.0+000 (RHS) is mentioned which is not recommended by PIU for approval. Therefore, the duly signed revised utility laying plan required to be submitted showing "only" the water pipeline to be laid along/across the NH on the basis of recommended hindrance free locations by PIU-Hazaribagh. Further, the offsets, Dia. & type of carrier/casing & Ch. Km. of water pipeline shall also be duly mentioned in utility strip plan.
- (iii) As submitted by you vide letter dated 28.02.2025, Para 8(c) that, the stretch of NH-31 from Ch. Km.1+222 to Ch. Km.4+100 pertains to forest area. Therefore, the

'NOC' of forest department for laying of water pipeline in the recommended stretch must be submitted.

- 3. Also, as per Ministry circular issued vide OM no. RW/NH/33044/29/2015/S&R(R) dated 22.11.2016, the application shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
- 4. In view of above you are kindly requested to invite Comments of general public for subject captioned proposal on "What's New" of NHAI website & Ministry's web site for 30 days from the date of uploading. "Further, the compliance of observation as brought out in para 2(i, ii, iii) above shall be complied while recommending the proposal for approval of Competent Authority please".
