Invitation of public comments

Sub:- Permission proposal for laying underground 3Km long 12.75 inch dia City Gas distribution network and 125mm dia.MDPE (Medium Density Poly Ethylene) pipeline along with 40mm OFC duct from Km 0/000 to Km 3/000 (between Sharjapur to Bagalur) along NH 648(Old NH-207) in the state of Tamil Nadu-Reg.

The proposal is regarding request for permission for laying underground 3Km long 12.75 inch dia City Gas distribution network and 125mm dia.MDPE (Medium Density Poly Ethylene) pipeline along with 40mm OFC duct from Km 0/000 to Km 3/000 (between Sharjapur to Bagalur) along NH 648(Old NH-207) in the state of Tamil Nadu by the applicant M/s Indian Oil Corporation Limited, Southern Region Pipelines, Krishnagiri and Dharmapuri City Gas Distribution Project submitted to this office by the SE (NH), Salem vide letter No. 3114/2023/DO/NH dated 05.10.2023. The proposal has been examined and the details are as under:

2. The Right of Way in the stretch of NH proposed for laying underground cable line is 19.00m to 29.70m. The carriageway width of stretch from Km 0/000 to 3/000 of NH-648 is 12.00m. M/s Indian Oil Corporation Limited, has proposed to lay the underground Public Utility at the Extreme edge of the ROW for a length of 3000m by adopting open cut method/HDD method along the National Highway. Out of 3000m length in NH 648(Old NH -207), 2280m is proposed to be laid through open cut method on earthen berms and 720m is proposed to be laid through HDD method on earthen berms.

3. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 the application will be made available for public comments and the comments will be invited within 30 days from the day of uploading the same in the web site of Ministry of Road Transport & Highways for public comments.

4. In view of the above, comments of the public are invited if there is any objection/claim (on ground of public inconvenience, safety and general public interest) on the above proposal to the below mentioned address:
