**SUB:** Construction of Eight lane Vadodara Kim Expressway from Km 292.00 to Km 323.00 (Manubar to Sanpa Section of Vadodara Mumbai Expressway) in the State of Gujarat under NHDP Phase - VI on HAM mode (Phase IA-Package III):-

- Proposal seeking ROW permission for laying 220KV D/C Wagra TSS Line across Vadodara Mumbai Expressway **between Km 295+000 and Km 295+100** at Village-Derol, Taluka-Bharuch, District-Bharuch in the state of Gujarat.
