- SUB: Six Laning of Ahmedabad to Vadodara section of NH-8 from Km. 6.400 to Km. 108.700 (Length 102.300 Km and Improvement of Ahmedabad-Vadodara Expressway from Km 0.000 to Km. 93.302 in the state of Gujarat (Length 93.302 Km.) under NHDP Phase V on Design, Build, Finance, Operate & transfer (DBFOT) Toll Basis.
 - Proposal seeking ROW Permission for laying of 450mm Dia Water Pipeline across National Highway-48 at Km 15+400 on Ahmedabad-Vadodara section of NH-48 in the state of Gujarat.
