Sub: NHAI, PIU - Coimbatore - Request for Right of Way permission for laying of Under Ground Water Pipe Line along the NH boundary from km 177/234 to km 177/884 on RHS. And across the Road at km 177/609 using Dia 76.2mm PVC water pipe using in Dia 152.4mm MS casing pipe on NH-544 (Salem - Cochin Section) - Reg.

1. The proposal is regarding permission for laying underground water pipe line on the above said project chainages by Open trench method for a length of 650m and road crossing @ km 177/609 by HDD method by the Executive Officer, Ettimadai Town Panchayat, Kandhe Gounden Chavadi, Coimbatore District.
2. The Executive Officer, Ettimadai Town Panchayat has furnished an undertaking to accept any claims raised by the Authority, if any and the same will be paid by them and also furnished undertaking not to damage other utility, if damaged, then to pay the losses either to NHAI or to the concerned agency.
3. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by the Executive Officer, Ettimadai Town Panchayat, Kandhe Gounden Chavadi, Coimbatore District, will be made available for 30 days seeking public comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
