It is to inform all concern that M/s MSEDCL. letter under reference (3) has submitted a proposal for the subjected work and PD, PIU-1, Nagpur has recommended the above proposal vide letter under reference (1) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by that M/s MSEDCL is across Maharashtra / Chhattisgarh Border to Wainganga Bridge section of NH-53 in the State of Maharashtra is as follows:

- Underground crossing at km 462.420, km 462.400, km 458.500, km 456.060 & km 455.320 on Maharashtra / Chhattisgarh Border to Wainganga Bridge section of NH-53.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
