Sub: “Four Laning of Dolabari to Jamuguri section from Km 17.300 of NH-37A to Km 25.552 and from km 27.500 to 36.110 near Jamugurihat (km 182 of NH-52) in the state of Assam under SARDP-NE, phase on EPC mode”: Proposal for laying of 4-inch dia. CS Pipeline for Gas distribution through open cut method & HDD method along & across the NH-715 from NH Ch.27+900 to Ch.28+665 with crossing at Ch.28+665 in Sonitpur District -Reg.

The GM(P), PMU-Tezpur vide letter no. 240001/NOC/NHIDCL/Tez/19421 dated 08.08.2025 has submitted a proposal along with recommendation to obtain permission for laying of 4 inch Carbon Steel pipeline along the NH-715 from NH Ch.27+900 to Ch.28+665 (length: 756 m) & crossing at Ch.28+665 (length: 60 m) in Sonitpur District. The applicant, North East Gas Distribution Company Limited had submitted their proposal to the PMU vide their letter no. NEGDCL/GA11.03/NHIDCL/2025-26/08 dated 02.07.2025. The GM(P), PMU-Tezpur has certified the proposal, checklist and drawings as per the extant practice.

2. The subject cited NH Section has been developed to a 4 Lane facility.
3. As per Ministry's circular no.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 and subsequent modifications dated 17.04.2023 and 24.04.2023, the Highway administrator will make available the subject proposal on the portal for 30 days seeking for public comments on ground of public interest.
4. In view of the above, the comments of the public are invited on the captioned proposal and the same should reach the below mentioned address till 30 (thirty) days from the date of public interest.
