Sub: 4 laning of MP/Maharashtra Border-Dhule section of NH-3 from km 168.500 to km 265.000 in the State of Maharashtra under NHDP Phase-III on DBFOT Basis -Proposal for permission for crossing of pipeline at km 236.522 for the Sulwade Jamphal Kanoli Lift Irrigation Scheme, Dhule -Reg.

It is to inform all concern that Minor Irrigation Dept. Dhule vide letter under reference (2) has submitted a proposal for the subjected work and PD, PIU Dhule has recommended the above proposal vide letter under reference (1) for approval of the Competent Authority / Highway Administrator i.e. Regional Office, Nagpur.

2. The alignment proposed by Minor Irrigation Dept. Dhule is across subject work as follows:

- Underground crossing at km 236.522 on Bodhare to Dhule section of NH-52.
3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
