Sub: Balance works for four laning of Amravati-Chikhali section of NH-6, Package-I [km 160.000 (Near Amravati) to km 220.000 (Near Kurankhed)] section of Amravati-Chikhali NH-53 in the State of Maharashtra to execute on Hybrid Annuity mode under NHDP Phase-IV- Proposal for laying of electrical cable from km 165.700 to km 168.200 on LHS through Pole to Pole Method and crossing at km 165.700 though HDD Method-Reg.

It is to inform all concern that M/s MSEDCL letter under reference (2) has submitted a proposal for the subjected work and PD, PIU, Amravati has recommended the above proposal vide letter under reference (1) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by that M/s MSEDCL is across Amravati -Chikhali Pkg-I Section of NH-53 (old NH-6) in the State of Maharashtra is as follows:

- Laying 11KV electric line Pole to Pole and crossing at 165.700 through HDD method.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
