Sub: Four laning of Waranga - Mahagaon from km 253.700 to km 320.580 Section of NH-361 in the State of Maharashtra under Bharatmala Pariyojana on Hybrid Annuity Mode - Proposal for permission for laying of 11KV Electric underground cable road crossing at Chainage km 265.970, km 268.500, km 270.350, km 272.160, km 275.060, km 280.335, km 284.420, km 284.800 on NH-361 under RDSS Scheme of Waranga-mahagaon section of NH-361, Total length -480m in the State Maharashtra- Reg.
