Chief Officer, Bhagur Municipal Council, Nashik and Executive Engineer, NH PWD, Nashik's vide letter cited above has submitted Proposal for Laying of 250mm dia. Water Supply Pipeline from Km. 29.600 to Km. 26.100 on LHS (length 2.5 Km) along with (Ghoti-Sinnar Section) of NH-160A for approval of the Competent Authority, Highway Administration.

2. From the submitted proposal, it is observed that, the Laying of Water Supply Pipeline is proposed near Sakur Phata, Nashik from Km 26.100 to Km. 29.600 (LHS) (Total Length - 2.5 Km) along NH-160A.

As per Para-4 of Ministry of Road Transport & Highways (MoRT&H) Circular No. RW/NH-33044/29/2015/S&R(R), Dtd. 22.11.2016, the Highway Administration shall put out in the Public Domain for 30 days for seeking claims and objections (On grounds of Public inconvenience, safety and general public interest).
